The underpads have sealed edges for optimum leakage protection, and the surface is covered with a soft nonwoven material for optimum user comfort. In addition to helping to provide peace of mind when sitting or lying down, the disposable pads also help reduce the risk of contamination and increase hygiene. ABENA Tissue Underpads are available in different sizes and with either six or eight layers of tissue.
